# Supplier Evaluations

After zeroing down on the potential supplier we help analyze the pricing after taking into consideration key parameters such as variety, quantity, technical specifications, shipping, insurance and local inspections, duty etc. to have the material delivered to your doorstep or port of choice.



Depending on your requirements, we conduct raw material inspection followed by overall supervision of the entire product and assembly lining by conducting initial product inspection & during product inspection.



After post production inspection our team implements a stringent Quality Control measure to ensure the final produced goods meet exactly what your specifications are. This is followed by a pre-shipment inspection, keeping in mind your packing & billing instructions. We also assist in container consolidation from various vendors along with container loading supervision.


